**August Demonstrator – Ken Terrell**

**KEN TERRELL: CARVING, PIERCING AND FLUTING TECHNIQUES**

Ken has been interested in wood working for many years. In late 1995 he was introduced to hollow vessel turning by two friends in the West Texas and Houston area. After setting in on turning sessions at the Cutting Edge in Houston, he was hooked.

Having had a background in metal fabrication, Ken built a large diameter lathe which he utilizes to date.

After retiring to Tyler in 1996 and joining the East Texas Woodturners, his chief interest was in turning large hollow vessels. He admits to having an extremely large “humble pile” of turnings that made great firewood.

Following an impressive seminar by Frank Sudol, the potential of carving and piercing on hollow vessels created a new direction. In 2002, he invested in a flexible shaft carver and began experimenting with piercing and then followed with carvings on hollow vessels.

Ken's demo will briefly touch on his techniques for piercing, fluting and carving, along with tool requirements, etc.

## Ramblings

Two upcoming pieces of business are to be dealt with at the next meeting. First it is the time for our Annual election of officers. The nominating committee consists of Larry Genender, Larry Roberts, Devore Burch, Fred Denke and Alan Siebenthal. And once again Alan was appointed while he was not in the room, if you know what I mean.

The timetable is as follows; at the September meeting the nominations will be announced and we will vote at the October meeting. We will continue to take nominations until the vote is taken however, in order to include as many candidates as possible. All offices are open for nominations as we elect (or re-elect) each year for one-year terms. We are also considering adding a couple of new positions. One would be the office of Webmaster and the other, an Audio/Visual director. These would have to be approved by revising our By-Laws, which is the other item of business.

In July we formed a By-laws committee to review and propose changes or improvements on our Chapter's By-laws. There will be a couple of additions, like the additional two Officers. There will also be a couple of revisions in wording to clarify the meaning of the existing wording.

The very nature of By-laws is very impersonal. A more personal way to run a Chapter would be to let everyone run it. The By-Laws, which by the way have to be approved by the AAW, allows us to control our Chapter in a legal, orderly way. But it is definitely not personal! The changes that are proposed DO NOT take into account, for instance, who holds a particular office. It simply states what that officer should and should not do. Please make every attempt to inform those on the Committee about your decisions regarding the proposals and they will be revised until approved. They will then be submitted for consideration to the National office of AAW. Once signed, they will take effect as the document that governs our Chapter.

The By-laws committee consist of Mike Wallace, Robert Brandt and Alan Siebenthal. A copy of the proposed By-laws will be made available at the end of the August meeting. Review them and we will ask for your vote on them at the September meeting.
